Use a corporate resolution template to identify which individuals are legally authorized to: sign official documents; make assignments or transfers; lease or sell real estate.

A corporate resolution for a bank account is a statement listing the names of officers authorized to do business on the corporation's behalf. Some banks have a blank form they ask corporations to fill out. The form typically contains fields for all the necessary information, including the name and address of the company and a statement about when it was incorporated. Any officers authorized to handle the corporation's banking must be listed.

What Should a Banking Resolution Contain? A banking resolution usually contains the name and address of the LLC, exactly as filed with and approved by the state. The document will also need to list the legal names of all employees and officers who are authorized to make transactions through the company account, including authorizing and depositing checks and borrowing money on behalf of the LLC. The resolution will also need to provide the date (and often, location) of the meeting when the ...

These resolutions are passed by the board, officially recorded by a corporate secretary and filed among a company's official records. The corporate resolution for signing authority is a specific corporate resolution that authorizes specific corporate officers with the legal standing to sign contracts on behalf of the corporation.
